GAME ON! Super Bowl XLIV Ticket Raffle II Official Rules & Regulations

Prize

Catholic Charities Archdiocese of New Orleans, a 501(c)3 organization, is raffling off two (2) tickets to Super Bowl XLIV, which are valued at \$800 per ticket (\$1,600 for two tickets). Super Bowl XLIV will be located in Miami, FL on Sunday, February 7, 2010. The prize does not include hotel accommodations or transportation. All raffle tickets sold will benefit the Archbishop's Community Appeal (ACA), the annual fundraising campaign to support the work of Catholic Charities Archdiocese of New Orleans. Super Bowl XLIV tickets were generously donated by Rita Benson LeBlanc and the New Orleans Saints.

Raffle Tickets

Raffle tickets are \$100 each. A maximum of 1,000 raffle tickets will be sold. Tickets are available on a first come, first serve basis. There is no limit to the number of tickets an individual may purchase.

Raffle tickets will be sold Wednesday, January 20, 2010 – Wednesday, February 3, 2010 from 10 AM – 2 PM at 1000 Howard Avenue, 1st floor (business days only). Visa & Mastercard, cash and checks accepted. Checks should be made payable to Catholic Charities Archdiocese of New Orleans.

Online raffle tickets go on sale Wednesday, January 20, 2010 at 10 AM at www.ccano.org. Visa, Mastercard, American Express and Discover cards accepted. Individuals who buy raffle tickets online will be emailed their raffle ticket number within 24 hours of purchase by a designated employee of Catholic Charities Archdiocese of New Orleans. A raffle ticket stub will be completed and entered in to the GAME ON! Super Bowl XLIV Ticket Raffle by a designated employee of Catholic Charities Archdiocese of New Orleans.

No raffle tickets or money for raffle tickets may be sent through public or private mail.

A dishonored check will be considered an invalid raffle ticket and the entrant will be notified if this is the case.

Only individuals may purchase raffle tickets. Raffle tickets will not be issued to a business, group of persons, or more than one person.

The GAME ON! Super Bowl XLIV Ticket Raffle will be considered closed once the 1,000 maximum of tickets has been reached. In the case that the maximum number of tickets is not sold, the GAME ON! Super Bowl XLIV Ticket Raffle will close on Wednesday, February 3, 2010 at 12 noon.

According to the Internal Revenue Service (IRS), raffles are games of chance are not tax-deductible. Therefore, individuals who purchase GAME ON! Super Bowl XLIV Ticket Raffle tickets may not deduct the cost of the ticket as a charitable donation.

Selection of Winner

The winning ticket will be drawn by the independent auditing firm of Postlethwaite & Netterville on Wednesday, February 3, 2010 at 3 PM at 1000 Howard Avenue, 1st floor. Postlethwaite & Netterville will use a random number generator to choose the winning ticket.

Ticket-holders need not be present at the drawing to win.

Winner will be notified within 24-hours of the drawing by an employee of Catholic Charities Archdiocese of New Orleans and will have one (1) week to collect the Super Bowl XLIV tickets from Catholic Charities Archdiocese of New Orleans at 1000 Howard Avenue, New Orleans.

The winner will be notified by telephone, email, or U.S. mail, according to the contact information provided to Catholic Charities Archdiocese of New Orleans at the time of raffle ticket purchase.

If the winner cannot be notified by 5 PM on Thursday, February 4, 2010, after making reasonable attempts to do so, or if the winner is deemed to be ineligible, such winner will be deemed to have forfeited his or her prize and another winner will be selected for such prize.

The name of the winner may be obtained by a request, in writing, to Catholic Charities Archdiocese of New Orleans together with a self-addressed, stamped envelope, no later than April 30, 2010.

Eligibility

Only Louisiana residents are eligible to participate in the GAME ON! Super Bowl XLIV Ticket Raffle.

Individuals must be 18 or older to participate in the GAME ON! Super Bowl XLIV Ticket Raffle.

Employees of Catholic Charities Archdiocese of New Orleans (including PACE Greater New Orleans and Second Harvest Food Bank of Greater New Orleans & Acadiana) and their spouses and dependents are not eligible to participate in the GAME ON! Super Bowl XLIV Ticket Raffle.

General Terms & Conditions

By purchasing a raffle ticket, you agree to be bound by these Official Rules & Regulations and the decisions of Catholic Charities Archdiocese of New Orleans, which will be final.

Prize winnings are fully taxable under Federal and State of Louisiana law. The estimated value of the prize is \$2222.23. The winner will be issued IRS Form W-2G in this amount for tax year 2010. Federal and State of Louisiana income tax withholding in the amount of \$622.23 is included as part of the prize (Federal - \$555.56, State - \$66.67). As required, the withholding tax will be remitted to the taxing authorities by Catholic Charities Archdiocese of New Orleans. Catholic Charities Archdiocese of New Orleans will NOT be responsible for any individual income taxes over the amount included in the prize.

The winner must complete form W-9 with a valid taxpayer identification number.

The winner will be required to sign a publicity release permitting Catholic Charities Archdiocese of New Orleans to use his or her name, photograph, likeness and voice for any promotional purposes in any media.

Catholic Charities Archdiocese of New Orleans is not responsible for any injuries, losses or damages of any kind arising in connection with or as a result of the winner's acceptance or use of any prize.
